<b>1</b>	<p>Just few days ago we have been able to download from your website the Invitation for the submission of bids for the procurement of good in the open procedure: Procurement subject: Purchase of 5 new solo low floor buses with electric drive with charging equipment (34144910 – Electric Buses), no. VND – 302/15</p> <p>Because of the fact that:</p> <ul style="list-style-type: none"><li>- the submission of bids must be within 21 December 2015</li><li>- the bid must be submitted in Serbian language</li></ul> <p>the time is too short to allow us to submit the bid within the 21<sup>st</sup> of this month.</p> <p>We kindly ask you to postpone the date of submission to February 29, 2016 also because of Christmas and New Year Holidays.</p>

<b>1</b>	<p>We are informing you that we do not have possibility to postpone the deadline for submission of bids for procurement of goods in open procedure; Procurement subject: Purchase of 5 new solo low floor buses with electric drive with charging equipment (34144910 – Electric Buses), no. VND – 302/15 February 29, 2016.</p> <p>Public invitation for the submission of bids for public procurement of goods: Јавни позив за подношење понуда за јавну набавку добара: PROCUREMENT SUBJECT - PURCHASE OF 5 NEW SOLO LOW FLOOR BUSES WITH ELECTRIC DRIVE WITH EQUIPMENT FOR CHARGING (34144910 – Electric Buses), no.
